- Section 1.4.4 The proposal requests 1 original copy and 1 electronic copy. Can the electronic copy be submitted on a jump drive? Answer: Yes.
- Section 1.4.4 Please give an example of opaque packaging? Answer: In this instance, opaque means that you cannot see through it, so any solid type of packaging will be acceptable.
- The cost proposal should be submitted as "hard copy" and no electronic copy? Answer: Yes.
- "Abandonment of existing 6" AC Pipe w/Flowable Fill" is on the bid sheet twice, once on page 30 & again on page 31? Answer: Please disregard the second pricing request on page 31.
- 6",8",10", & 12" MJ Gate Valve Assembly is on the bid sheet twice, once on page 30 & again on page 31? Answer: Please disregard the second pricing request on page 31.
- Page 31 Please be more specific for "Valve Insertion", depth, pipe material, etc.? Answer: This would be to insert a valve into a live water main buried using either TEAM Valve, AVT, or HYDRO-STOP gate valve insertion products,

or any approved equivalent, on ductile or cast iron lines ranging in sizes 6", 8", 10", and 12". May be utilized as an isolation valve on hydrant leads. Depth of the water lines is going to vary anywhere from 3.5 feet to 5 feet.

- Page 31 What is the estimated quantity of meters what need testing per contract? Answer: Approximately 250 meters annually
- Page 31 Please specify a quantity for Mulching DS-1, Temporary Grassing DS-2, Permanent Grassing DS-3, & Permanent Grassing DS-4, possible change to square yards instead of lump sum? Answer: Square Yards is fine.
- Page 30 " Traffic Control. Scope of daily? Hourly? Answer: Hourly is fine.
