### Question and Answer

Question: A copy of the winning proposal from your current fireworks vendor for both your 4<sup>th</sup> of July and End of Summer show, including shell counts and price contracted for.

Answer: We will post the current contract on the website along with the Addendum. However, unlike most Items posted, this document will not be considered as part of the final contract. The contract renewal is part of this addendum with current pricing.

Question: Please clarify the shell sizes requested for these events.

Page 13- July 4th display states "4 and 5 inch shells ONLY,

but further down: Each show..low level through aerial shells with a maximum size of 5 inch.

Answer: ONLY 4 and 5 as you correctly stated for the 4th of July show.

They can propose whatever they want for the price for shells ranging in size of 1" - 4" at the Labor Day weekend show on Sunday, September 2<sup>nd</sup>.
